NOTICE INVITING TENDERS (NIT) THROUGH E-PROCUREMENT

- 1.1 For and on behalf of the President of India, Commissioner, Directorate of Logistics, Customs & Central Excise, Dept. of Revenue, Ministry of Finance, Govt. of India, having its office at 4th Floor 'A' Wing, Lok Nayak Bhawan, Khan Market, New Delhi 110 511 invites e-tenders valid up to 180 days from the date of opening of tender, in two parts, namely, (1) Technical Bid and (2) Price Bid from tenderers who meet the qualification criteria laid down in Section VII for supply, installation and maintenance of 74 Nos. of VIDEOSCOPE at various field formations of CBEC. Videoscope should enable the Customs officers to view inaccessible areas during examination of goods at sea ports, air-cargo complexes, Inland Container Depots, etc. and should assist in identification and detection of contrabands and smuggling.
- 1.2 Details of the goods and services required, specifications, eligibility and qualifications to bid and instructions on how to bid and other details are available in the Tender Document which can be downloaded from official website (www.cbec.gov.in; HYPERLINK "<http://www.dolcbec.gov.in/>" www.dolcbec.gov.in) and on www.eprocure.gov.in from 22.03.2018 to 04.05.2018. Last date of receiving clarification on tender is 05.04.2018 upto 15.00 Hrs. The pre-bid conference will be held on 12.04.2018 at 14.30 hrs. at the address given below at para 1.5.
- 1.3 The tenders can be submitted online up to 13.00 hrs. on 04.05.2018. The tenders will be opened online at 15.00 hrs. on 07.05.2018 at Office of Directorate of Logistics, New Delhi. In the event of any of the above mentioned dates being subsequently declared as a holiday / closed day for the purchase organisation, the tenders will be received/opened on the next working day at the scheduled time.
- 1.4 Interested tenderers may download the tender enquiry documents (TED) and upload their tenders online only at Central Public Procurement Portal website: <https://eprocure.gov.in/eprocure/app>.
- 1.5 Earnest Money Deposit (EMD) for Rs. 22,00,000/- (Rupees twenty two lakhs only) in the form of Bank Guarantee and a non-refundable Tender fee of Rs. 5,000/- (Rupees five thousand only) in the form of account payee demand draft / bankers cheque, drawn on a scheduled commercial bank in India, in favour of "PAO, O/o the Pr. C.C.A., C.B.E.C." payable at New Delhi, must reach at the address given below by 04.05.2018 at 13.00 hrs. Tenderers, however, have to attach scanned copies of EMD & Tender fee along with the Technical bid of their e-tender.
