CIRCULAR

Sub: Appointment of Superintendent, now re-designated as Additional Assistant Director (AAD) on deputation basis in the Directorate of Logistics, Customs & Indirect Taxes, New Delhi-reg.

One post of Superintendent, now re-designated as Additional Assistant Director (AAD) in the pre-revised pay scale of Rs. 9300-34800 + 4800/5400 Grade pay & Level 8/9 (as per 7th CPC) is likely to fall vacant shortly in the Directorate of Logistics, Customs & Indirect Taxes, New Delhi. All Group 'B' Gazetted officers in the analogous Pay Scale working in the Commissionerate/ Directorate/Custom House under Central Board of Indirect Taxes & Customs are eligible for appointment on deputation to this post. The period of deputation is initially three years and can be extended by one year at the discretion of the Appointing Authority and for a further period of one year on mutually agreed basis.

2. Officers who apply for the said post will not be allowed to withdraw their candidature subsequently. However as and when a situation arises a premature reversion to his parent Commissionerate/Directorate may be given to the officer.
3. The age of the officer should **not exceed 56 years** as on closing date of this circular.
4. It is requested that names of suitable and willing officers along with their APARs grading for last five (5) years, Vigilance Clearance and History of Posting may be forwarded to this office **latest by 28.06.2019**, along with "No Objection Certificate" from the concerned Commissionerate/Directorate.
5. The Officers who have already applied in response to the circular dated 22.04.2019, of this Directorate, need not apply again.


