Terms and Conditions

- 2. All the content shall be editable by the administrator of the DoL office with login protection.
- 3. Website shall support uploading of various reports which shall be reflected

on the dashboard.

- 4. Website should work in all the browsers and shall be secure.
- 5. Hosting of the website shall be the responsibility of the vendor. Proper training needs to be provided to the administrator by the vendor.
- 6. FAQ, Feedback, Visitors watch shall also be part to the Website updation.
- 7. The following needs to be ensure while developing software for online schemes.
- a. These online schemes need to be secure and credentials based.
- b. All the records shall be maintained in the database and Date of submission of request, any modification of request and status change needs to be recorded.
- c. An automatic password generation needs to be implemented and administrator shall not be able to view and modify the password/username of the Users.
- d. Implementation of Roles and rights shall be controlled by Administrator.
- e. All the reports shall be customizable and Columns shuffling and search facility needs to be provided.
